

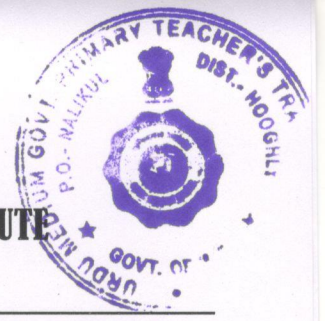

ADMISSION NOTICE FOR 2nd MERIT LIST

(Regarding Admission into "2 Year D.EL.ED. Course" for the Session: 2025-2027)

1. The 2nd merit list displayed on the notice board and in the official website of the Institute is provisionally approved by WBBPE.
2. Having a rank in the Merit lists does not guarantee admission. Admission is strictly subject to the verification and authentication of the stated percentage of marks, date of birth, category, medium, academic qualifications, validity of Boards / Councils/Universities etc. **with the original certificates, documents and testimonials.**
3. **Self-attested of Date-of-birth, Mark-sheet of H.S. or equivalent, Cast, P.H., Aadhar card along with 3 copies of recent passport size colored photography to be submitted at the time of admission.**
4. **Only prescribed fees are chargeable as per WBBPE instruction (Rs. 7700/-).**
5. For date of birth M.P. or its equivalent examination Admit Card/Certificate shall have to be verified in addition to Verification of other documents uploaded by the applicant. The date of birth shall be recorded as in the M.P. or its equivalent examination Admit Card/Certificate. **In case of difference the head of the institute may treat the application invalid.**
6. If an applicant fails at any stage of such verification of details, his/her candidature will be cancelled by the authority of the Institution without referring the matter to the WBBPE for decision. The Institution authority will only forward a report of such cancellation to the Board.
7. The Female candidates must have to bring their parent or elder of the family (in absence of parent) as their guardian.
8. Right to being enlisted in the SC/ST/OBC/PH/EWS category is reserved for candidates belonging to such categories, in terms of the valid certificates, issued by the competent authorities.
9. No vocational category candidate is eligible for the non-vocational-category-seats.
10. An enlisted candidate may be denied admission, if there is mismatch between the statements made and the documents, produced at the time of admission.
11. Subsequent Lists may be released only, if seats remain vacant category-wise after the expiry of the last date of reporting for admission in terms of the Second List.
12. **Classes will started immediately after getting admission.**
13. 80% attendance in regular classes and 90% attendance in Internship both are mandatory during the said courses vide WBBPE's memo no. **38/WBBPE/D.El.Ed/2023 dt. 06.02.2023.**
14. Biometric attendance is mandatory vide SCERT memo no. 1289/F.No.-639 (Pt-II)/SCERT dt. 13.07.2025
15. **The admission will be taken on 13/10/ 2025 to 15/10/ 2025 on 11.00 A.M. to 2 P.M. sharply.**
16. **The above instruction must be followed strictly.**
